1. The Club has rented to the Member a space to store his/her golf clubs and motorized golf cart.
2. The Member hereby specifically acknowledges that he/she is responsible to purchase liability insurance regarding the use, operation and ownership of said motorized golf cart.
3. The Member hereby specifically agrees to indemnify and hold harmless the Club for any and all damages, causes of action, claims, demands, or other requests for pecuniary damages arising from the Member's use, operation, or storage of the Member's motorized golf cart on the Club's premises.
4. The Member further acknowledges that he/she is fully responsible for the use and operation for the motorized golf cart either by himself/herself or any individual that he/she should permit or suffer to use the motorized golf cart.
5. The Member specifically acknowledges that the Club has no obligation to provide liability insurance relating to said motorized golf cart.
6. The Club hereby provides written notice to the Member that the Club's insurance policy specifically excludes from the insurance coverage the Member's private property stored upon the Club's premises.

1. The Member has leased a motorized golf cart from the Club for use on the Club's premises.
2. The Member hereby specifically agrees to indemnify and hold harmless the Club for any and all damages, causes of action, claims, demands, or other requests for pecuniary damages arising from the Member's use, operation of said motorized golf cart on the Club's premises.
3. The Member further acknowledges that he/she is fully responsible for the use and operation for the motorized golf cart either by himself/herself or any individual that he/she should permit or suffer to use the motorized golf cart.

Sample schedule of charges for damages: Headlight (each) \$100, Windshield \$155, Leaning left or right \$150, Mid/Rear body repairs \$300, Bench seat cut or burn \$150, Seat back cut or burn \$100, Steering repairs \$250, Front cowl repairs \$300.

Membership Definitions:

Family Memberships with Children shall be for the member, his/her spouse or domestic partner. All unmarried children of his/her family until said female or male children reach age 19 or unless full time student, then age 22. Must provide names and ages of children on membership form when joining.

Family Memberships without Children shall be for the member and his/her spouse or domestic partner and does not confer membership upon his/her family.

Single Membership shall be for the individual only and does not confer membership upon his/her spouse or family.

High School - College (Student Membership) _____ - such membership shall be open to all persons from the age of 12 until graduation from high school, college or graduate school. Said membership shall be open to all such persons who are not members by any reason of family membership must be full time students until age 23. Must provide current Student ID and Driver's license upon request. **When you turn 23 you are not eligible for student pricing.**

The Senior and Military discounts are not applicable.

Member & Guest Membership Good for one guest accompanied by a member. One guest per visit per membership per day. Good during open golf only, no tournaments etc. **The Senior and Military discounts are not applicable.**

Guest passes are **\$20.00** each. There is a limit of 10 guest passes per membership. Guest passes may only be purchased at the kick-off party or up until May 1, **2026**. New members may purchase guest passes only at the time they join. **GUEST PASSES EXPIRE OCTOBER 31, 2026.**

All memberships are subject to Board approval
