### From the Desk of Executive Director

January is National Human Trafficking Prevention Month. Despite increased awareness in recent years, there remains widespread confusion. The U.S. Department of State defines "human trafficking" and "trafficking in persons" as umbrella terms used to refer to both sex trafficking and compelled labor. In this heinous crime, traffickers exploit adults and children, compelling them into labor or commercial sex for profit.

Within the United States, the predominant forms of human

trafficking are forced labor and sex trafficking. Shockingly, research from The Human Trafficking Hotlines indicates that <u>40% of the victims in South Dakota have been</u><u>minors</u>.

Youth within the child welfare system, particularly those in out-of-home placements, are frequent targets of sex traffickers. Those experiencing homelessness, poverty, substance abuse, neglect, physical violence, sexual abuse, or involvement in the juvenile justice system are also at elevated risk. The National Foster Youth Institute estimates that up to 60% of child sex trafficking victims have been in foster care, highlighting the urgent need to address this public health and social justice crisis.

Moving beyond the adage "see something, say something," and ACT is crucial. To deepen my understanding and contribute to prevention, I have joined the South Dakota East River Human Trafficking Task Force. In collaboration with Call to Freedom, CASA is actively delivering Human Trafficking prevention training at local Child Protection Meetings and supporting schools in our service area. Together, we aim to combat trafficking, providing essential support and healing to victims.

CASA staff stood against human trafficking on January 11, #EndTraffickingDay. We are committed to raising awareness and fighting this global issue.
