How Did "We" as Americans Get to Where We are Today - a Strong Government Concentrated Economic, Pro-Growth Development Institution?

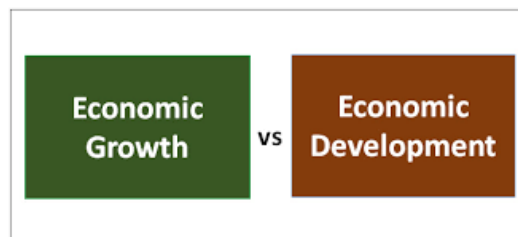
In order to understand further, we must go back to the beginning to understand what we escaped from, the British-Monarchical, International Roman Feudal System of Trade Companies.

As I write in a prior story, the Land of the Virginia Land Company, the following passage tells of how America originated from

"America" it all began the year Christopher Columbus landed on the continent October 12, 1492, in present day El Salvador in the name of Spain. Thought to have landed in Southwest Asia, this triggered many explorations in the years ahead by France, Spain, and later on, England. However, it was a German cartographer named Martin Waldseemüller who had derived the name from an international system of names or terms in relation to terms as established by rules in forming the terms in a particular field of arts and science, after the Italian explorer, "Amerigo Vespucci" who had explored the two continents on behalf of Spain and Portugal shortly after Christopher Columbus' death in 1506. This had triggered a series of explorations led by several European countries, first by Spain, then Portugal, France, and finally England all during the 1500's thus claiming lands in different parts of the continents over the first hundred years. By 1606, the English-speaking countries, Great Britain, Ireland, Scotland, began staking claims in the Northeast Territory, when in the name of King James, they established the first colony. That was the year that King James had issued a "Charter" to a group of men known as the "adventurers" often referred to investors and settlers, to be known as the Virginia Company of London, or most times referred to as the Virginia Land Company.

One of these groups of people were known as the Pilgrims, to whom migrated first from the Germanic regions to England, and then to Ireland, before migrating their way to "America" to push forward their intention of promoting the Christian, Protestant faith. By 1620, they arrived on the shores of Plymouth Rock, and pronounced upon themselves, a proclamation that read:

IN THE NAME OF GOD, AMEN. We, whose names are underwritten, the Loyal Subjects of our dread Sovereign Lord King James, by the Grace of God, of Great Britain, France, and Ireland, King, Defender of the Faith, &c. Having undertaken for the Glory of God, and Advancement of the Christian Faith, and the Honour of our King and Country, a Voyage to plant the first Colony in the northern Parts of Virginia; Do by these Presents, solemnly and mutually, in the Presence of God and one another, covenant and combine ourselves together into a civil Body Politick, for our better Ordering and Preservation, and Furtherance of the Ends aforesaid: And by Virtue hereof do enact, constitute, and frame, such just and equal Laws, Ordinances, Acts, Constitutions, and Officers, from time to time, as shall be thought most meet and convenient for the general Good of the Colony; unto which we promise all due Submission and Obedience.



Due to the distance between the Pilgrims and the centralized English government, ordinary men found themselves in leadership positions they wouldn't have otherwise held. John Robinson, had counselled the Pilgrims to choose as leaders those who "diligently promote the common good," and not to begrudge "in them the ordinariness of their persons, but God's ordinance for your good". For the first time, a moral understanding of localizing government control in the hands of the people became the norm, while using a set of God's codes became the means to guide us.

The influence of the Mayflower Compact has far outlasted and outgrown the Pilgrims' original intent. Legally, it was superseded when the Pilgrims obtained a patent from the Council of New England for their settlement at Plymouth in 1621. However, the Compact had already gained symbolic importance in the Pilgrims' lifetimes, as it was considered important enough to be read at government meetings in Plymouth Colony for many years.

Over the next hundred years, America's form of government began to take hold, and by the mid 1700's, a transition away from British Rule, became the pathway to Individual, and Sovereign rule.



Organization of American States

The Confederation of American States for the United States of America

Alongside, you had the Ulster-Scots, the Pilgrims, and the Germanic Tribal people migrating to America between 1650-1750, thus the population within the colonies was fast expanding in Virginia, or the northeastern territory, where you had 13 colonies by 1760.

The majority of these colonies were tied to the British-Crown, by virtually, the Virginia Land Company, to whom they held the charters.

By the end of that first century on the North American continent, these groups of people, now in their 2nd and 3rd generations, began rising up, led by the Ulster-Scots and German people, you now see a mass-revolutionized people asking for their sovereignty.

In order to maintain control over them, Great Britain, the King, decided to push forward, agreeing to establish separate stations in what had come to be known as "British-America" ...

- Beginning in 1774, Great Britain and the Americans agree by adopting the "Articles of Association" which would be a formal agreement to begin that separation while working together to define each other's station, thus you see the territory being carved up in 50-50 equal areas, equally working together to govern over each their own.
- What first started with the People of Mecklenburg County in Carolina, when they adopted the Mecklenburg Resolves, ended in 1776, when the 13 Colonies adopted at-large, their Declaration of Independence, thus declaring themselves to be Independent, and Sovereign, making themselves "equal" to the King.
- Third, they, under Thomas Jefferson's Draft Ordinance of 1777, which would define a set of rights for the people of Virginia, (America), to which would see to present a pathway to defining their" political states, to which they would zone their respective states, to which would establish clear jurisdictional boundaries between Great Britain and the American States, and the people.
- These Original "American States" were seen as to be "Contemporary Political States" where the people would enact their state constitutions, set their own laws, and codes, side by side their British counterparts, hence, the two countries were seen as co-equals, both residing in America, only now, as two equal stations.
- By September 4, 1777, they had adopted the Articles of Confederation, creating the first "American Government" which would allow these newly created Political States to appoint up to 7 Delegates to a Continental Congress, to whom these delegates would elect an "American President" who would hold such office for one (1) year at a time.
- They had formed the United States of America, as a confederation of 13 Contemporary American Political States, each, to whom would be a sovereign nation in itself. Under their Continental Congress, the Delegates had agreed to meet in Philadelphia temporarily each year, for up to 90 days, to adopt a set of national policies related to commerce, grant treaties, and establish a uniform set of rules and codes for the 13 States to follow. They had even agreed to establish the First Bank of North America, to which each of the "states" would deposit taxes in, in order to provide to the President, funds to provide his services back to the states, mainly to act as an ambassador on behalf of the states in foreign countries.
- Then, came the Treaty of Paris of 1783, the British, the Monarch, the Holy Roman Emperor finally recognize the 13 United States as their own country, only to coax them into agreeing to pay back "restitutions" to the several investors and settlers of the Virginia Land Company, to whom had owned the land, as well, they had to agree to take on the debts owed by Great Britain, to the City of London.
- It would be these "restitutions", which is an agreement between the American States to restore or recompense the British of their injuries and loss of properties (and land) surrendered by the King.

You see, if the King was going to surrender his charters, give up his lands, he was going to ensure payment was not only paid back to him, the Crown, but to other British Lords, those persons of title within the peerage system. This was to become a 70-Year Promise to Pay, which began in the year 1783, and would come fully due by the year 1853.

From 1777, and for the first ten years, the American People controlled the freedom, and sovereignty of no centralized power ruling over them. All powers derived locally, where they acted as townships, to whom were governed by their state constitutions. They would elect State legislators to whom appointed Delegates that formed a National Congress, to whom set national policies, a budget, agreed to treaties, and through means of an a **Committee of States**, acted as a supervisory, Executive Department to manage our National Departments of the Treasury, State, Interior, and War. The committee of states was made up of at least one delegate from each state, to whom elected one of them to act as the American President to whom represented the country abroad.

All taxing authorities reside locally, within each of the American States, which of course, were led by a moral code, as defined by their Christian God, to whom we led by means of divine ordinances.

But also, we must keep in mind, in 1775, the British had incorporated the name United States of America as a corporation, a trade company in the City of London, and this meant, that the British had maintained a sense of control on America, side by side the Americans, to whom in 1777, created the Un-Incorporated United States of America, acting as 13 Sovereign States.

1. The Incorporated United States of America was a "**British Trade Company**" (London)
2. Un-Incorporated United States of America is the **American States acting as one "Nation"**

Two totally separate "stations" acting simultaneously on the American Continent. And in 1788, those more loyal to the British, the Federalists, adopted the Constitution of the United States of America. And knowing that 4 of the 13 American States had not yet agreed to the constitution (North Carolina, South Carolina, Rhode Island, Georgia), George Washington was elected, or chosen by a 'British Trade Company'. From 1789-93, the Constitution was adopted, thus creating a "Government for the United States of America, thus recreating a "territorial government" to be placed in a neutral area aka "The District" giving the British and the American People a neutral place to manage all foreign affairs between each other.

From that point on, you had these two 'stations' working together, to manage the Territorial United States Government, acting through the constitution, providing services to the American States.

And then, that financial arrangement, agreed to in 1783, had come due in 1853, and during Franklin Pierce's four year term, (1853-1857), Presidents James Buchanon and Abraham Lincoln supervised over, a 'transition' from the sovereign, American Republic, to what has since, been referred to as the

"British-Roman Municipal Government"



During a period between 1860 to 1893, the U.S Territorial Government would become 'vacated' as well, and a third U.S Government created, this would begin a 30 Year War Between the States.

What Happened:

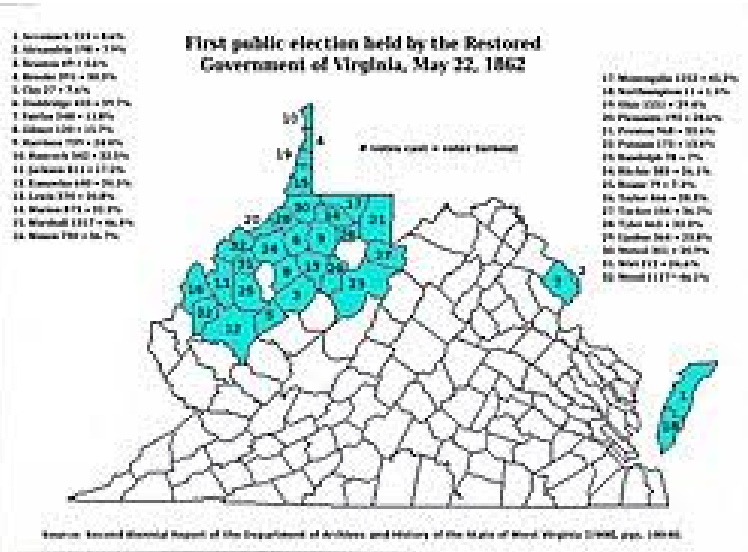
1. **Defined Southern Congressman** between 1859-1863 as **Rebellionists**.
2. Removed them from office, arresting them, etc.
3. Adopted **General Order 100** that created a Federal Militarized Territory incorporating ALL Federal Property in the States.
4. Adopted the **Emancipation Act**, freeing Black Slaves, Prisoners of War, bonding them to Lincoln's Iron-Clad Oath to Defend and Support the Federal Government.
5. The City of London (Bank) gained control of the "District of Columbia" Loaning it huge sums of money to control them, use them, and create this new territory.
6. The Attorneys contracted themselves to the British B.A.R Association, bound to British Law.
7. Amendments 13, 14, 15 all adopted.
8. **ACT OF 1871** adopted creating an ORGANIC ACT to Create the District of Columbia Incorporation Act - creating a United States Land Company, giving it a Governor, Secretary, Treasurer, Judicial System.
9. They were creating **NEW Federal States in this Territory**, which mirrored the "Federal Militarized Territory.
10. They **granted Immunities, Civil Rights, U.S Citizenship Status** to Black Slaves, Prisoners of War, and All Americans that Bonded themselves to the Territory.
11. As each "State" Federal District " now gets 30,000 U.S Citizens, they became new states, giving to them 2 Senators, 1 Representative.
12. This allowed Congress to Reseat the Senate and House filling the "Vacated Seats" all bound to their new oath.
13. They then passed the **1872 Amnesty Act**, to grant Amnesty to all "Ex-Insurrectionists" as long as they become U.S Citizens and Promise to Obey the New Rules. Remember - President Johnson had already 'pardoned' many of them prior.
14. In **1874**, they adopted the **D.C Municipality Act**, creating a Permanent D.C Government - Mayor, 9 Member Council, Committees, Commissions, Police, Jail System, Ordinances for the Territory - **United States Land Company.**
15. The UNITED STATES LAND COMPANY uses "Bank Loans" to buy out all Assets, Charters of the Virginia Land Company aka the South.
16. **Virginia splits in two, forming West Virginia.**
17. By **1880**, the UNITED STATES was now enslaved under an Administered, Federal, militarized "State" called United States Land Company, new departments, offices, agencies would be created between 1890 to 1990.
18. In **1893** - the **Federal Govt contracted, and formed a partnership with the Rothchilds, Morgan-Belmont Syndicate**, a group of private bankers who had agreed to all the U.S Treasury Bonds, allowing the Federal Government to restock the treasury, with bank notes. The members of this syndicate became known by the contract as the following - Drexel, Morgan Co, the J.S Morgan Co, and N.M Rothschilds and Sons. **The Federal Reserve was created 20 years later.**
19. 100 Years later (1972), Nixon pardons Jefferson Davis freeing his family to become naturalized into the new "Federal States.'
20. 100 years later (1977), Carter pardons General Robert Lee, freeing his family to become naturalized into the Federal States.

The period of 1860 to 1880 was a Coup led by British Bankers, Foreign Born Persons, Attorneys, to hijack the Government, create a Provisional Govt (1871), and form their permanent Govt (1874), contracted to the Bank itself (1913).

Do You See it? They Created a Third U.S Government - today, there is a U.S Militarized, Administered Municipal Corporate Government.

Today, within the District of Columbia, you have the U.S Militarized Administered Municipal Corporate Government which operates by means of the President, the Agencies, the Non-Profit Organizations.

NORTH-WESTERN VIRGINIA CONVENTION.
FIRST DAY.

The Convention assembled yesterday at two P. M., in Washington Hall.

On nomination of F. H. Pierpont, Dennis B. Dorsey, Esq., of Monongalia co., was selected as temporary Chairman. G. L. Cranmer, of Wheeling was, on nomination of Campbell Tarr, of Brooke, chosen temporary Secretary.

The President returned his thanks briefly for the distinction conferred. He said that taking the chair as temporary Chairman it would be superfluous in him to allude to the vital subjects that would come before the Convention. They had calmly and thoroughly considered them at home and had now come here to act on those reflections. He realized that this was to be the most important Convention that ever assembled in the State of Virginia. He would not impose a speech on the Convention, but would merely say that he would endeavor to discharge the duties imposed on him to the best of his ability.

On motion of Mr. Pierpont, Rev. G. Battelle, who was present, was requested to open the sitting of the Convention with prayer.

 This is a partial clip of an article in the June 12, 1861 issue of *The Wheeling Daily Intelligencer* that summarized the first day of the first session of the Second Wheeling Convention.

During this period, here is an interesting story about what actually happened in Virginia, and how the "Federal Government" may have violated the constitution, by creating a state from another state, without the consent of the majority of the State itself:

The Creation of West Virginia between 1861-1863

- So, When VIRGINIA seceded from the Union, the Federal Government right away, put in place a "Territorial Government" which established the **"Restored Government of Virginia"**.
- The Federal Government conspired with the People in the "western" part of Virginia, to restore the Territory of Virginia.
- The Wheeling Convention was mostly made up of "Union-Loyalists" and those in the western side of Virginia.
- These delegates to the convention had met in Maryland, in close proximity to Washington D.C in order to hold safe, guarded public meetings.
- While the People of Greater Virginia had seceded and joined the Confederate States of America, Abraham Lincoln conspired with the 'western counties' of Virginia to reorganize, the Destinies of Virginia, and expelled a rebel government from the area. This is recorded evidence, that "D.C" had basically planned on creating a state from another state, which violated, and went against the Constitution.
- "The Wheeling Convention, after occupying nearly an entire day in debating the ordinance for reorganizing the State Government, finally adopted it—73 to 3. The principal discussion was upon a proposed amendment, providing that no one who voted for secession should be allowed to hold office in the State during the war. It was rejected—66 to 10. The ordinance as passed provides for the entire reorganization of the Government—every officer to be obliged to swear allegiance anew to the United States, and to repudiate the acts of the Richmond Convention. The next business before the Convention was the choice of a new Governor and Council; and for the former FRANK PIERPONT, of Marion, was selected."
- So, during the Civil War, which is said to last between 1861-1865, the Federal Union Government itself had intentionally created West Virginia by barring and keeping the 'rebellionist' from attending the conventions.

Article 6, Section 3, reads as follows,

"New states may be admitted by the Congress into this union; but no new states shall be formed or erected within the jurisdiction of any other state; nor any state be formed by the junction of two or more states, or parts of states, without the consent of the legislatures of the states concerned as well as of the Congress."

So, if the constitution for-bid "states" to be formed from within other states, did Abraham Lincoln, let alone the Federal Government fully admit that "states" have the right to secede?

IF the People of Virginia had declared their "sovereignty" and their right to leave the Union, then Washington D.C had no authority over the land, let alone the people themselves.

This is truly a conspiracy, and if true, the People of Virginia have been lied to, had their land stolen from them, and deserve reparations.

The Restored Government of Virginia gave its consent for the creation of a new state. A statehood bill was introduced to Congress, and after much debate, it was passed. President Lincoln signed the bill on December 31, 1862, and West Virginia was admitted to the Union six months later. The conventions held in Wheeling were critical in organizing resistance to secession and in laying the groundwork for statehood. The delegates' decision to form a new state was both a political and practical move to align with the Union and ensure their region's interests were represented.

The creation of West Virginia during the Civil War was unprecedented. It highlighted the complex interplay of geography, economy, and politics in shaping state boundaries. The new state played a strategic role in the Union war effort, providing vital resources such as coal and timber.

Basically, said, between 1865 to 1875, the Federal Government adopted the ACT OF 1871, incorporating ALL Federal territories, properties, and people as part of the union, before in 1874, created a permanent Municipal Corporate Government to govern D.C

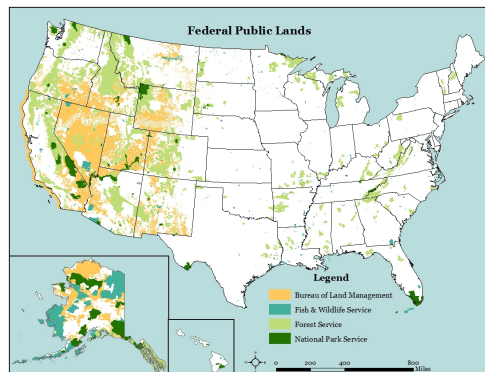
In the end, the 10 Southern States re-entered the Union, as newly reconstructed states, forced to agree to West Virginia as a State.

They then forced them to Change the Constitution adding Amendments 13, 14, 15, later on 16 and 17 by military force.

So, you tell me, is West Virginia a legally created state, or do the People of Virginia deserve reparations for the loss of their land, and territory?

From this point forward, the United States of America has since acted as a UNITED STATES Corporation, known today as the United States of America, a British-Roman Municipal State.

This "Militarized, Municipal Government acts by means of Article 1, Section 8, Clause 17, thus as an organized Military Organization, while utilizing Article 1, Section 8, Clause 13-16, by means of an Administrative, Tribunal Court System, to whom operate the country through the Bankers, to whom fund Judges, Attorneys, in order to maintain the peace, and welfare of the "entity".



In order to maintain their control, the Established Order holding authority over the United States Corporation, that land company, hands out a set of Tax Subsidies, Grants, Benefits, Loans, Allowances, and Credits to keep them silent, and busy today.

- **1870-1890** • Congress began "collecting data" on all Americans private and commercial through the process of "Collectivism" by means of banking acts, the settlement acts, and other acts that attempted to convince Americans of giving up their sovereign property rights through the means of license, certificates, and commercial contracts.
- **1890-1920** • Congress began the process of Corporatism whereas America began to encourage businesses to incorporate and attach themselves to the U.S Corporate Government (est. 1871), creating a period in time where Americans were contracting themselves ever more tightly to the federal government, thus doing business within federal territory.
- **1920-1950** • Congress dives into Fascism, creating policies which heavily regulate those corporations, with the intent to control foreign commerce across the 50 States who do business within that Federal Territory - hence Multi Nationalism became the hallmark tradition of today,, (Small Businesses began to de-platform).
- **1950-1980** • Congress begins to dive into Socialism, starting to engage with Americans, by creating policies expanding upon Social Security by means of Disability, Survivorship, Insurance Benefits, creating Medicare, Medicaid, and Other Social Platforms we have grown to expect of today., including the Affordable Care Act, let alone other forms of benefits.
- **1980-2010** • by 1990, Congress began to really work to align federal policies with more Global Policies, beginning to ship away, sell American tangible property rights off to foreign countries, businesses, persons with the goal of becoming more of a beneficiary of foreign labor, let alone seeking out, and gaining more foreign investments to fund federal roads, infrastructure, etc.

The Birth of the modern day "**capitalism**" was born, and today, we effectively have this new age, political movement under the umbrella of "**Pro-Growth, Economic Development**" that utilizes a federal tax dollars, in order to enslave the people, in order to enrich a select few elected, and appointed, and contracted Bankers, Attorneys, Judges, Real Estate Tycoons, bound to an International Cabul.

If the **Civil War** was about allowing the International Financiers, the Bankers to hijack, and take control of the North American Continent, then **World War 1** was about a classic re-organization of the European Continent, while **World War 2** was about allowing for the creation of a New World Order, a One World Government to Rise to Power, creating the **United Nations**, the **World Economic Forum**, the **North Atlantic Treaty Organization**, the **Zionist State of Israel**, as well as the **Bank of International Settlements**, as well as the **International Monetary Fund**.

Let's remember, the State of South Dakota was born of an Organic Act of Congress, thus Establishing Dakota Territory, to which, allowed for 14 Year Old Teenager Females to marry, 16 Year old Old Teenager Males, to whom along the way, young teenagers beginning at age 13 could become employed, at 14 - they could drive on public roadways, and by 16, they begin to be married. It would further be, during the 1920's, the South Dakota State Government learned of how to profit from Federal Tax Dollars, by means of the Creation of Mount Rushmore, to which provided a national spotlight, on the state itself, while allowing the "Government" to reap trillions of dollars of revenue through federal taxes, to which the majority derived from the Federal Reserve System.



Abraham Lincoln's Concept of Internal Revenue

“Internal” is defined as, relating to, or occurring on the inside of an organized structure (a territory), inside of the body, within the limits of the body itself.

“Revenue” is defined as, total income produced by a given source, that a political unit profits from through a collection of the national revenue as collected from the tax payers.

Now think of the I.R.S or, the Internal Revenue Service, what was it actually created for? Well, to best answer this question, read the next section:

They, the I.R.S cannot place a Lien on your property, garnish your bank account, paychecks, levy your income without going before a federal court.

Remember who really is in charge here, the 'secretary of the treasury' is and he must sign off on any action first. The I.R.S has no jurisdiction outside of D.C. IT is simply a collection agency to collect debt. IF you allow them into a "state court" and allow them to collect a debt, ordering a state judge to write a judgement to collect the debt by any means (garnishment, levy property, take property) that is YOUR FAULT. In this scenario, the state judge would be corrupted, taking a bribe or 'payment' to violate the constitution. YOU need to challenge the claim, motion the case to federal court, then force the "federal law' into the courtroom, before a Trial by Jury of your Peers.

When you force the I.R.S to present the law that says you owe an income tax, they cannot, because it does NOT exist.

Because the IRS only has authority to "**internally**" evaluate, assess, audit, levy, and collect from federal officials, officers, agents, employees, contractors, benefactors of public taxes (welfare servants), etc.

When you do this, you begin to learn, the federal government, a "corporation itself" used Abraham Lincoln's own logic, when he created the Internal Revenue Office in 1862.

He did so in order to apply an income tax, '**internally**' on all federal officials, officers, agents, military persons, employees, contractors to whom earned an income from the 'taxes' collected by the government itself.

Thus, Internally, based on Lincoln's IRON CLAD OATH, they pledged their loyalty to the federal government, to defend it, protect it, to serve it in times of war, hence the so-called Civil War, which really was not a civil war between the states themselves.

Lincoln's 1040 was nothing more than a way to contact these "federal persons" to file an assessment, or claim for income earned 'internally', thus they owed a tax on the net income as defined by law. Not only that, but for those to whom purchased U.S Treasury Bonds, to which, deposited revenue into the treasury, earning them back 3% profit, were also forced to submit a 1040 by the end of the year, hence, you have the definition of '**1040 Revenue bonds**'

So, as America was reconstructed back together as one nation, the congress between 1865-1875 at the time, minus people from 10 southern states, put the country back together under military law - forced these new federal states to accept amendments 13, 14, 15 (later on 16 and 17), created a provisional territorial government (1871) for the territory, while by 1874, created the British-Roman Municipal Corporate Government for the territory, thus creating USA INC, to whom in 1890, partners with the Rothschild-Belmont-JP Morgan financial syndicate, allowing them to purchase U.S Treasury Bonds, which they turned and sold for "profit" to foreign investors, to then loan back to the USA INC giving them revenue to do their thing, to whom earn 8% Annual Annuity Payment every year thereafter.

There was no promise to ever pay back the national debt to these bankers. They were ok giving them trillions of dollars of revenue, so long as that new government coaxed the idea of creating a private bank (1913), and coaxing Americans to maintain the promise of that Annual Annuity payment, which became in 1909, the corporate excise tax act, so Multi-National Corporations would now participate in this **financial crime syndicate scheme**.

By 1920, the Rockefellers, Morgans, Carnegies of the country, joined forces, created the **C.F.R** or council of foreign relations, to work together to draft, and create foreign policy, to agree to buy up all of the top media sources (newspapers at the time) to control what you and I read every day. These large corporate masters now can control the government, now as USA INC, pass our laws.

Enter the New Deal Years (1930-1940). **Social Security**, forced Americans into a public trust, the **Gold Reduction Act**, forced Americans to surrender ownership of their gold, the **Public Works Programs**, thus forcing the government to raise tons of revenue, by creating 'federal employees', the **federal minimum wage act**, thus placing those employees on a minimum tax threshold, and finally, the **Public Salary Tax Act**, thus using Lincoln's idea of an "internal revenue scheme" to 'tax' federal persons, --- officials, officers, agents, employees, contractors, tax benefactors, both federal and state public persons --- "you" were tricked into buying U.S Treasury Bonds, under a program titled "Social Security".

These persons would now be forced to pay '**internally**' an income tax where they profited from public taxes as defined by Article 1.

However, in 1941, the Victory Tax was passed, encouraging Americans to participate in the system, and volunteer 3% of their income to the federal government to support the War effort, thus becoming Patriots. The act was repealed in 1945, without telling people, and some Americans continued to pay the tax, hence it became a **gift tax**. "Victory Tax" as in, "Win the War, and We will provide you a One World Governmental System" providing economic development to all participating countries, to whom agree to latch onto newly created International Building Codes, Fire Codes, Sustainability Programs, and more...

By 1954, congress amended the public salary act, by adopting the **Internal Revenue Tax Act**, thus creating the W-4, W-9, Wage contracts, thus forcing corporations to force private Americans into the system, by calling themselves federal employees. Thus, under non-disclosure, and ignorance, Americans give up themselves, by filing 1040 Assessments, thus claiming they earned an income in public. 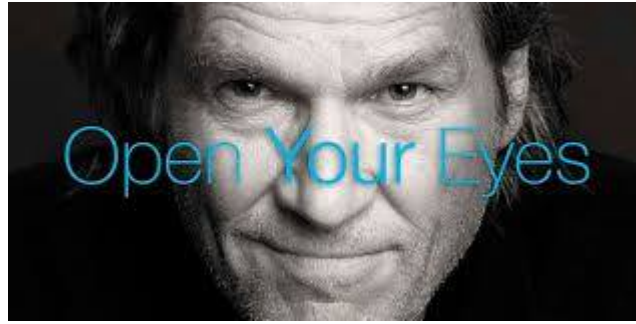

And always remember, the Secretary of the Treasury is in fact the "Authority" to collect such a tax, not the I.R.S nor its commissioners, nor their agents, nor their employees.

This is why, I encourage you to put EXEMPT on your W-4, claiming NOT to be a federal taxpayer under the law, thus keeping 100% of your Gross Income minus the social security and Medicare taxes (excise taxes) paid on your behalf by employers, to whom you now can keep your "income free from income tax" thus using it as you see fit.

There is no law that requires you to file a 1040, thus no need to incriminate yourself by signing your name on such legal form, at least until you begin to claim your Social Security (and Medicare) to which later in life, you must file a 1040 at that time to collect your retirement benefit from the public trust. So before that date, which is age 62 at the earliest, you must stand on your rights to be free, and to force the IRS to present this law, that requires you to do such thing, and if they cannot present such law, the JURY of YOUR PEERS must rule in your favor. And "WE" are the JURY. So, if we stand on this tax strike together, 'we' become the jury on each other's defense, as we take our individual cases into a federal court.

All the while, your "Government" utilizes the Corporate Media, Newspapers, Hollywood, any of their contracted entities to deceive you, trick you into giving up your total sovereignty to your person, land, and real property, in exchange for paying a property tax on land, an income tax on your income, all to fund their corporate masters, to whom your Public Officials - Presidents, Congressmen, Governors, Legislators, State Government Workers, County Commissioners, Judges, Attorneys, County Officials, Officers, to Mayors, City Councilors, to Municipal Employees, to all Appointed Officers contracted to your Governments - they all 'act' in fraud, to money launder from you, in the old adage, "Economic Development".

A writ of quo warranto is a common law remedy which is used to challenge a person's right to hold a public or corporate office. A state may also use a quo warranto action to revoke a corporation's charter. When bringing a petition for writ of quo warranto, individual members of the public have standing as citizens and taxpayers.

Ex parte Sierra Club, 674 So. 2d 54 - Ala: Supreme Court 1995, the Court noted that the writ of quo warranto is "utilized to test whether person may lawfully hold office and the purpose of writ of quo warranto is to ascertain whether office holder is constitutionally and legally authorized to perform any act in, or exercise any functions of, office to which he or she lays claim".

Folks, keep your faith in God, as long as we follow his word, maintain the peace, and act in a humane, respectful manner, justice will come for all of us. "WE" are living in an awesome period. Fraud is being exposed.
