- I Pledge to take my Public Salary and donate it to Charities, Purchase School Lunches for Children in K-12 Education, let alone utilize it to Help Homeless Shelters, Promote Local Taxidermy, and to help fund Local Historical Places throughout the City.
- I Promise as an Elected City Councilor to Utilize Section 2.09 to Subpoena Public Officials, Officers, Agents, Employees, all

Members of Local Non-Profits, and Agencies being funded by Public Tax Dollars to Investigate, Audit, and Call Into the Open How Our Public Taxes are being spent, much less Given.

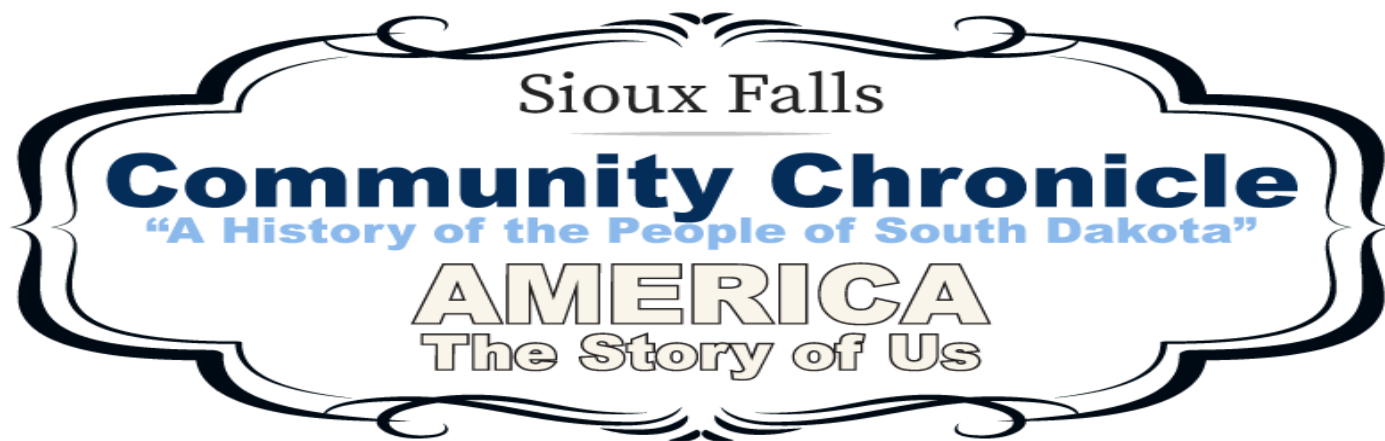
- To Promote the Establishment of a New Natural Wildlife, Nature, and History Outdoor Theme Park and Museum, thus promoting our localized Natural Wildlife, Awesome History, and Providing Local Hunters, Trappers, and Wildlife Creators - a Local Taxidermy Museum.
- To Promote the Establishment of a Future Use for the Sioux Falls Arena, searching for New Direction for the Facility, as used for Family, Youth, Entertainment, a Place of Refuge for the Homeless Community, a Place for Afterschool Programs, Summer and Winter Time Activities, and Other Awesome Events for Central Sioux Falls.
- To Promote the Establishment of a New Public Office to be Under the City Council itself, to be titled "Government Financial Transparency and Accountability Office" to be operated by 3 Nonpaid, Appointed Citizen Advocates, to whom would work with the City Council and Mayors Office to track revenues, expenses, let alone further Investigate, Audit, and Review City Programs, Services, Public Infrastructure, Roads - Providing back to the City Council the means of producing its own Citywide Budget, with the Goal to slash spending to be more in-line with Local Taxes.
- To Promote the Establishment of a Local, City Precinct Men and Women Central Committee, allowing the voters to have their own 'elected' committee of men and women to help initiate future ordinances,

refer ordinances adopted by the City Council, let alone seek out and find new people to be placed on future public ballots.

- To Promote the Creation of the West Sioux Falls Business District, giving it a board of directors, creating the entity to promote the commercial, entertainment, and culture of the area between I-29 and Main Avenue, and North Russell to the north, and Madison Street to the south. The goal is to utilize public revenues raised from business activities, to redevelop, and rebuild public streets, infrastructure, while promoting its historical significance to the community, let alone promote it as the Entertainment District of the city itself.
- To become a Prudent and Fiscal Leader of the City, someone who understands the State Constitution, the City Charter, and the Community itself, let alone take seriously the overall interests of all people of our community.
- To Promote the better use of Tax Increment Financing to fit the general nature of promoting Affordable Housing, Rebuilding Our Core Neighborhoods of the City, and a stronger, more effective community led development plan.
- I would Conduct at least One (1) Community Learning and Listening Town Hall Forum Each Month to Bring the Residents Together each and every month, thus allowing the Residents to become active within their Community, and to be More Involved in City Politics.
