## I Wanted To Plant 50 Trees

#### • Local school needs trees, nature



### City Ordinance

- Planting many trees is too costly
- Planting trees in the parking strip is often illegal
- Various other stifling city requirements
- City apparently prefers bleak concrete to tree-lined streets
- I cancelled my plans to beautify a local school setting

#### A Definition

- Parking strip a strip of land between the sidewalk and the curb that is not built upon but beautified with turf, trees, flower beds, etc.

#### City Ordinance Problem 1

- "§ 94.037 STREET TREES PERMITTED.
- (a) The director shall maintain a list of approved street trees.
- (b) The director may approve species other than from the approved list when the planting of the species is of equal or greater benefit to the city."
- Better to say "Deciduous trees may be planted in the parking strip"

- "§ 94.038 PLANTING IN PUBLIC RIGHTS-OF-WAY."
- "(1) No person shall plant or allow a tree to be planted in the right-of-way without a permit subject to the provisions of this chapter;"
- That's a nuisance
- "(2) Only approved trees may be planted in the parking strip;"
- Adds needless difficulty, reduces variety

- "(3) No tree shall be planted where the clear space between the curb and the sidewalk is less than five feet;"
- Prevents planting trees
- "(4) No tree shall be planted closer than three feet from the curb;"
- Prevents planting trees
- "(5) Trees must be one inch in diameter or larger measured six inches above the ground;"
- Increases cost, prevents mass plantings

- "(6) Trees shall not be planted under power lines unless approved by the director;"
- Should read "Dwarf trees may be planted under power lines"
- "(7) Trees shall be planted at least 40 feet apart except where otherwise permitted by the director;"
- Stifling. Plant as many trees as you like
- "(11) Trees on a corner lot shall be planted at least 30 feet back from the corner"
- Big trees are higher than cars & don't block vision <sup>9</sup>


- "ARBORIST'S LICENSE § 94.060 REQUIRED."
- "No person for hire ... may perform tree maintenance or remove trees within the city unless the person ... holds a valid arborist's license"
- Licenses protect established businesses, are a barrier to entry, increase cost, encourage expensive consumer safety
- Law prevents maintenance workers trimming twigs
- License requirement should be limited to big jobs 10

- "§ 94.035 PERMIT TO REMOVE; REQUIRED."
- "(a) No person shall remove trees in public places without first procuring a permit from the director."
- Is this necessary? Do city staff get formal permits?

#### Conclusion, Recommendations

- Does the city want trees or control?
- Encourage tree-lined streets stop preventing them
- Simplify ordinance
- Lighten up
- Encourage nature and trees
